#### Summersville Loop Schedule Changes

The Summersville Loop route has been in operation since July 5, 2016 and after careful consideration and a compilation of statistics, it has been decided that we will make changes to the schedule effective on Monday, October 31, 2016.

The Loop bus will no longer be stopping at Summersville Manor or the Summersville Public Library. Service to these locations will continue to be available on our Call-A-Ride service. Turnout at these locations has been consistently low.

Along with this schedule change, Save a Lot and Lowes will now be request basis only. We believe that these changes will allow for more efficiency in the Loop route, therefore, creating more ridership which will allow us to continue this route.
